NEVADA SUNRISE ACQUIRES CLAYTON NE PROPERTY IN CLAYTON VALLEY, NEVADA

DECEMBER 10, 2015, Vancouver, British Columbia - Nevada Sunrise Gold Corporation ("Nevada Sunrise" or the "Company") (TSXV: NEV) is pleased to announce it has entered into a definitive agreement for an option to purchase a 100% interest in the Clayton Northeast lithium property ("Clayton NE"), located in the Clayton Valley in Esmeralda County, Nevada.

Clayton Northeast Property

Clayton NE totals approximately 684 acres (276 hectares) and is contiguous to the Silver Peak lithium mine ("Silver Peak") operated by Albemarle Corporation (ALB: NYSE). A Silver Peak lithium production well is located approximately 45 metres from the Clayton NE western boundary.

In the United States Geological Survey ("USGS") Open-File Report 82-415 (1982), it is reported that a historical drill hole (CV-5) is located on Clayton NE. Hole CV-5 was drilled to a depth of 479 feet (146 metres) and encountered lithium values in ground water ranging from 24 parts per million ("ppm") to 110 ppm lithium, averaging 69.3 ppm lithium for a group of 11 samples, and averaging 65.75 ppm lithium for another group of 12 samples, analyzed both in the laboratory and in the field. The historical drill hole was part of a 1977 regional drilling program carried out by the USGS. Nevada Sunrise believes that drilling deeper holes at Clayton NE could intersect additional aquifers potentially hosting brines of similar or better contents of lithium than were encountered in the relatively shallow historical hole.

Details of the Option Agreement for Clayton NE

For an option to purchase a 100% interest in Clayton NE, Nevada Sunrise has agreed to pay a total of 500,000 common shares of Nevada Sunrise to the vendor upon signing a definitive agreement (the "Agreement") for the Property, and on subsequent anniversaries of the Agreement, as follows:

•	On signing the Agreement:	100,000 common shares
•	1st Anniversary:	150,000 common shares
•	2nd Anniversary:	250,000 common shares

A 1.5 mile (2.25 kilometer) area of interest applies to the Property. Clayton NE is subject to a 3.0% gross overriding royalty ("GOR"). On the 3rd anniversary of the signing of the Agreements for Clayton NE, Nevada Sunrise would have the right to purchase 1.0% of the GOR for US\$1,000,000.

The option agreement for Clayton NE is subject to acceptance by the TSX Venture Exchange.



About the Clayton Valley

In 2013, the USGS released a report describing the Clayton Valley's potential to host lithium deposits based on the hypothesis that lithium is liberated by weathering of host rocks or derived from hydrothermal fluids from a variety of rock sources within a closed basin. The floor of Clayton Valley has an area of about 100 square kilometers and a catchment of about 1,400 square kilometers, and is the lowest (topographically) of at least five adjacent basins that are hydrologically linked by groundwater flow (Zampirro, 2004). It is the combined area of all five linked catchments that makes the effective area of the Clayton Valley lithium-brine system much larger than the footprint of the Clayton Valley proper (*Source: from USGS Open File 13-1006, 2013*).

John R. Kerr, P. Eng., is the Company's designated Qualified Person within the meaning of National Instrument 43-101, and has reviewed and approved the technical information contained in this news release.

About Nevada Sunrise

Nevada Sunrise is a junior mineral exploration company with a strong technical team based in Vancouver, BC, Canada, that holds interests in five exploration projects in Nevada, USA. Our three key gold assets include a 21% interest in a joint venture with Pilot Gold Inc. (TSX: PLG) at Kinsley Mountain near Wendover, a 100% interest in the Golden Arrow project near Tonopah, and a 100% interest in the Roulette gold property in the southeastern Carlin trend near Ely, with each of the properties subject to certain production royalties. Nevada Sunrise began acquisitions of Nevada lithium properties in September 2015, which include an option to earn a 100% interest in the Neptune Project in the southern Clayton Valley area. The Clayton NE property near Silver Peak is the Company's second acquisition in the field of lithium exploration, and a third acquisition, Jackson Wash, is pending.
